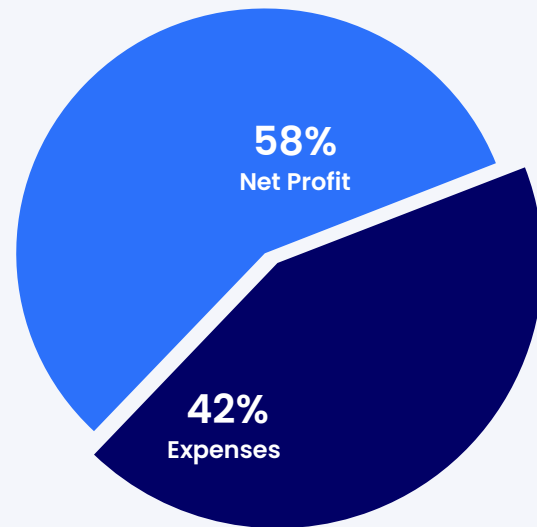

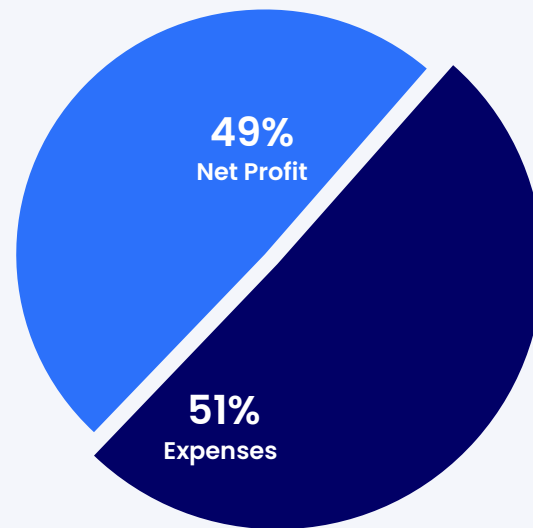

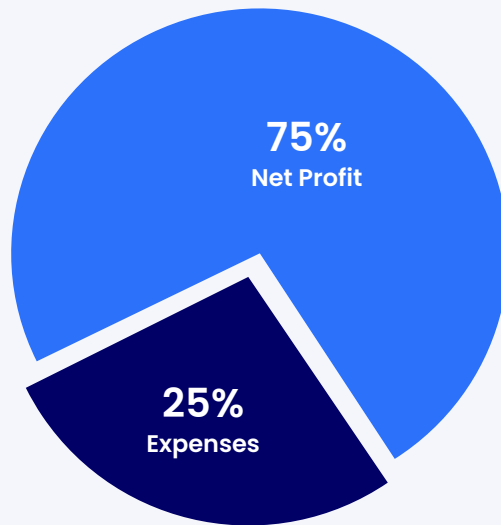

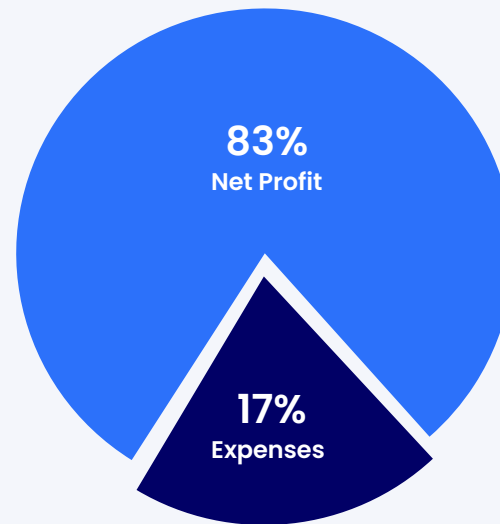

Path to \$100K in 6 Months



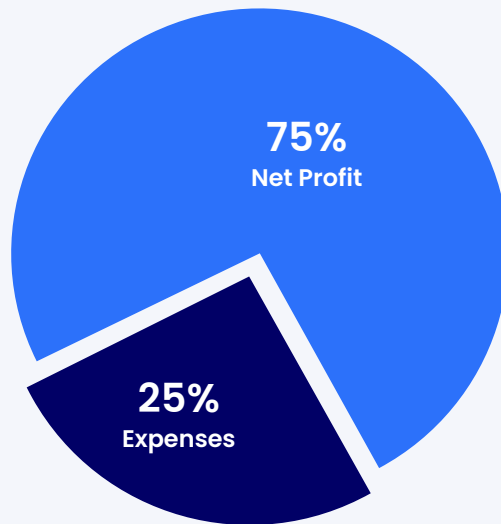
